# 15/30-hour funding and tax-free childcare policy

# 15-30-Hours family working funding

Children in the term after they are 9 months old in England may be entitled to 30 hours family working government funding per week and the maximum number of funding that can be claimed is 38 weeks. These hours can be stretched throughout the year.

Children who are not eligible for family working extended offer of 30 hours will be eligible for 15 hours in the term after they have turned three years.

## Will my child be eligible?

Your child will be eligible for 15 or 30 hours if:

- Your child is 9 months old, and you can claim the term after they are this age (term dates are 1<sup>st</sup> Jan 1<sup>st</sup> April and 1<sup>st</sup> Sept)
- You, and any partner, must each expect to earn (on average) at least £167 per week (equal to 16 hours at the National Minimum or Living Wage).
- If you, or your partner, are on maternity, paternity, or adoption leave, or you're unable to work because you are disabled or have caring responsibilities, you could still be eligible.
- Eligible working families can get up to 30 hours childcare.
- 15 hours of childcare is available for **all** families in England (the term after they are three years)

## **Tax-free Childcare**

From September 2017 Tax-Free childcare will help working parents with the cost of childcare offering up to £2,000 per child per year, or £4,000 if a child is disabled. You will be able to open an on-line account to pay for your childcare costs with a registered childcare provider and for every £8 you pay, the government will add £2.

Parents can use Tax-Free Childcare alongside the 15- and 30-hours government Childcare schemes. Parents can't use Tax-Free Childcare at the same time as they receive childcare vouchers, Universal Credit, or tax credits. However, 30 hours childcare can be received alongside these schemes.

When you apply, you'll be considered for both these services through the same application. You'll only be asked to decide which support you want if you're on tax credits or using a childcare voucher or salary sacrifice

scheme. You should check what help you could get with childcare costs, using the Childcare Calculator. This will help you decide which support is best for you.

# How do you apply for Tax-Free or 30 hours government funding Early Learning?

It is important that you check your eligibility before the start of the term in which you wish to claim

For example, if your child is due to start their 3-year-old place in April 2025 you can check your eligibility the term before from January 2025– March 2025. If you do not find out that you are eligible (or you do not become eligible) before 1<sup>st</sup> April, you would not be able to claim until the term after, in this example, that would be September 2025.

You will need (for you and your partner, if you have one):

- National Insurance number
- If you're self-employed, your Unique Taxpayer Reference
- The date you started, or are due to start work
- Details of any other government support you get

At the end of the application process, you will have a childcare service account. In the 'secure messages' section of your account, you will receive messages about your eligibility.

If you are eligible for 30 hours, you will receive an 11 digit 'eligibility code' for your child. You will need to bring this code (along with your National Insurance number and your child's birth certificate or passport) to nursery so that we validate your child's eligibility with the Local Authority and confirm your place. This has to added on the BCP Parents declaration form that has been attached to this funding policy.

Every three months HMRC will prompt you to reconfirm your details as entered on your initial application. If you do not do this then you will receive a message telling you that your eligibility has lapsed. Although you will no longer be eligible you may be able to retain your childcare place for a short period; this is known as the grace period. You will need to discuss this with nursery. You will still be able to access the universal 15 hours. This is a parental/carer responsibility, and the Nursery cannot be responsible for any reminders.

#### **Attendance**

As a provider, we must inform Bournemouth, Poole and Christchurch council of any frequent poor attendance.

Please be advised that the above is based on our current free entitlement offering as set out. Puss 'n' Boots is open for 51 weeks of the year and we would like to allow parents to access the funded hours for the 51 weeks that we are open, rather than just term time only. This allows parents more flexibility throughout the year, and they do not then receive a large invoice for the weeks/months that are school holidays. We therefore ensure that your funded hours are **stretched throughout the term** to cover the holidays. Dependent on the length of the term the funded hours may vary i.e. the summer term is longer than the spring term and **therefore your invoices will vary**.

## How will Puss 'n' Boots deliver the 30 hours and 15 hours (38 weeks per annum)

#### **Enhanced Care for funded hours**

Early years Foundation Stage only provides the minimum requirements for early years care and education. However, Puss 'n' Boots Day Nursery invest far more into ensuring children have a rich, high quality early years' experience. With parents choosing to pay for the items and experiences listed above, these valuable experiences, trips, learning resources and comforts are possible.

The revised guidance explicitly states that many of the services we currently offer during our regular day at Puss 'n' Boots are not covered by the funding. Therefore, we have considered carefully whether to reduce the quality of our provision of the funded hours, or request support from our families through this non-mandatory fee.

We are absolutely committed to maintaining our standards of service where families are not expected to provide anything additional for their child whilst at Nursery and all our children have access to the same range of additional opportunities on offer. In order to maintain these levels, we hope all our families will continue their support by agreeing to the Enhanced Provision Fee.

If parents/carers are eligible for the deprivation entitlement, Puss 'n' Boots wish to support these families and are welcome to speak with the management team regarding further costings.

If you would struggle or are unable to pay the enhanced care charge, please feel able to discuss this with Kirsty or Fiona

Should you wish to withdraw your consent to the Enhanced Provision, please provide written notice, giving at least eight weeks' notice prior to the end of term for the following term. Once this notice has been provided, a meeting will be arranged with one of our Senior Management Team to discuss the implications on the future provision for your child.
